Initially, it was expected to start providing services and recognizing revenue within the 4th quarter of 2024. However, due to the need for careful selection of contracting companies and thorough data verification for accuracy and transparency, there has been a delay in selecting the contracting companies. Therefore, the company will start providing services and recognizing revenue within the 1st quarter of 2025.

The company Light Up Total Solutions Public Company Limited has undertaken the procurement and installation of servers to support the LLM Training system, with a delivery and activation schedule according to the planned timeline. However, during the server validation process, which is a crucial step to ensure that the servers can operate effectively and safely with the customer's system, delays have occurred due to uncontrollable external factors.

The reasons for the delay are:

1. The delay in preparing data from the client's side, which is necessary for system integration testing.

2. The server validation process by the manufacturer is delayed due to the conditions of the readiness test, resulting

in the process taking longer than scheduled.

3. The team needs to adjust the delivery plan to ensure that the server has passed all inspections before actual use,

for the long-term stability and reliability of the system.

The company would like to clarify that we have been closely monitoring the progress and coordinating with all relevant parties to expedite the operations so that the servers can be delivered as soon as possible. The company remains

committed to the principles of quality, safety, and readiness to provide system services according to the established standards.
