The Company would like to inform that on 19 June 2025, ENGH has subscribed the newly issued ordinary shares which issued and offered to the specific investor through Private Placement in the amount of 32,000,000 shares and completely paid by transferring ENS' shares at the amount of 100,000 shares, with a par value of 100 Baht to the Company. In this regard, the Company has already allocated the Company's newly issued ordinary shares at the amount of 32,000,000 shares, with a par value of 0.50 Baht as well as had completed the registration of the change of paid-up capital of 16,000,000 Baht from the existing paid-up capital of 103,300,000 Baht to the new paid-up capital of 119,300,000 Baht and the paid-up shares of 32,000,000 shares from the existing paid-up shares 206,600,000 shares to 238,600,000 shares with a par value of 0.50 Baht, with the Department of Business Development, the Ministry of Commerce.
